Privacy Policy

This Privacy Statement informs you about the types of information the Village of Comstock gathers online when you visit our website comstock@nctc.net or any of our associated web sites, how we may use that information, whether we disclose it to anyone, and your choices regarding our use of, and your ability to correct, that information.

This Privacy Statement may change from time to time, so please check back periodically.

1. Sites Covered by This Statement

This Privacy Statement covers the collection and use of data on our website Comstock@nctc.net and any affiliated sites managed by the Village of Comstock.

2. What Information We Collect

The information collected on our Site(s) generally falls into the following two categories: Personally Identifiable Information and Non-Personally Identifiable Information.

<u>Personally Identifiable Information</u>: This refers to information that lets us know the specifics of who you are. The Personally Identifiable Information we collect when you use our Site(s) may include: your name; mailing address(es); phone number(s); e-mail address(es); credit card number and expiration date; identification number; login names and passwords; public postings; employer; and job title.

We request Personally Identifiable Information when you: request a service; participate in certain promotional activities; fill out surveys; and correspond with us.

We also collect Personally Identifiable Information when you ask that we send information directly to other people; in these cases, we will collect the information you submit about the recipient.

Non-Personally Identifiable Information: This refers to information that does not by itself identify a specific individual. The non-personally identifiable data we collect when you visit our Site(s) may include the Uniform Resource Locator (see Notes) of the pages you visit on our Site(s) and our Internet Protocol (See Notes) address. This Statement also contains More Info about how we use cookies and other technology to collect this data.

We do not connect the Personally Identifiable Information and Non-Personally Identifiable Information we collect on our Site(s).

3. Why we collect your information

Our primary goals in collecting information are: to provide constituents with superior service, and to provide all visitors a smooth, efficient, and personalized experience while using our Site.

We use your Personally Identifiable information to process your request or provide the requested information. We use Non-Personally Identifiable Information on an aggregated basis to help us understand how visitors use our Site(s) and to measure interest in the various pages. We use this information to improve the content of our Site(s) and to make our Site(s) easier to use.

4. How We Use Your Information

We gather and use information in a number of ways, including the following:

<u>Surfing</u>: We collect certain Non-Personally Identifiable Information when you visit our Site. We collect this information to help run our Site(s) more efficiently, to gather broad demographic information and to monitor the level of activity on our Site(s). Learn more about how we use cookies and other technology to collect this information.

<u>Online Services</u>: We collect Personally Identifiable Information when you request services online, for example property tax payments. We collect this information to process your request, to obtain payment when applicable, and to communicate with you about the status of your request.

<u>Online surveys</u>: We collect Personally Identifiable Information from customers who volunteer to complete surveys. We use this information to improve our services.

<u>Newsletters and e-mails</u>: We collect Personally Identifiable Information when you ask to receive newsletters, e-mails, and other information. We use this information to provide you the information you request.

<u>Contact information</u>: If you contact us, we may keep a record of your correspondence or comments, including Personally Identifiable Information, in a file specific to you. We use this information to help us provide better service in the event you contact us again.

5. Sharing your information

<u>The Village of Comstock</u> will not rent, sell or give away any Personally Identifiable Information entered into the website to third parties for marketing or mailing list purposes. However, Your Personally Identifiable Information may be shared as required: for a third party to process the request, and otherwise by law.

Third Party Processing: The Village of Comstock will send Personally Identifiable Information about you to other companies, agencies, or people when: We need to share your information to provide the product or service you have requested. For example, we might use a third party billing company, and we send information for billing purposes only; and we need to send the information to companies who work on behalf of comstock@nctc.net to provide a product or service to you. Unless we tell you differently, these companies do not have any right to use the personally identifiable information we provide to them beyond what is necessary to assist us.

Otherwise by Law: comstock@nctc.net will send Personally Identifiable Information about you as required to do so by law, subpoena, court order or legal process.

6. Accessing and Changing Your Information

<u>The Village of Comstock</u> seeks to ensure that your information and preferences are accurate and complete. If you have registered at <u>comstock@nctc.net</u>, you may access and change your information by visiting the site where it was submitted. All e-mail communications from us, such as newsletters, tell you how to stop receiving them. Please follow these instructions if you no longer wish to receive the e-mail messages.

7. Use of Cookies On This Site

A "cookie" is a small data file transferred by a website to your computer's hard drive. You are sent cookies when you surf comstock@nctc.net make on-line payments, respond to online surveys, or request information. Accepting comstock@nctc.net cookies does not give us access to your Personally Identifiable Information, but we can use the cookies to identify your computer. The aggregate information collected permits us to analyze traffic patterns on our Site(s). This can enable us over time to provide you with a better experience on our Site(s) by improving the content and making it easier to use.

Most browsers automatically accept cookies, but you can usually refuse cookies, or selectively accept certain cookies, by adjusting the preferences in your browser. If you turn off cookies, though, there may be some features of our Site(s) that will not be available to you and some Web pages may not display properly. When you complete on-line transactions on our Site, we use Secure Sockets Layer ("SSL") encryption technology to safeguard your sensitive information while it is being sent to us. The SSL encryption is designed to make the information unreadable by anyone but us. This security measure is working when you see either the symbol of an unbroken key or closed lock (depending on your browser) on the bottom of your browser window.

9. Links to Other Web Sites

Parts of our Site(s) contain links to third-party websites for your convenience and information. If you use these links, you will leave the comstock@nctc.net website. When you access a non-comstock@nctc.net website, please understand that we do not control the content and are not responsible for the privacy practices of that site. We suggest that you carefully review the privacy policies of each site you visit. This Privacy Statement does not cover the information practices of those websites linked to our Site. These other sites may send their own cookies to users, collect data, or solicit personal information.

10. Children's Privacy Protection

The Village of Comstock believes that protecting children's privacy online is extremely important. The Village of Comstock_respects national and international laws, including the Children's On-line Privacy Protection Act ("COPPA"), which applies in the United States. comstock@nctc.net is not directed to children under 13, and does not knowingly collect personal information from children.
